

Notice Regarding the Management Integration of Consolidated Subsidiaries

ITOCHU ENEX CO., LTD. (headquartered in Chiyoda-ku, Tokyo; Tomofumi Yoshida, Representative Director, President and CEO; hereinafter "ITOCHU ENEX") announces its decision to integrate the management of its four wholly owned subsidiaries (see below). The details are as follows.

1. Purpose of the management integration

As the domestic LP gas market continues to shrink due to the declining population and aging society with fewer children, maintaining and expanding its nationwide customer base and sales network will be a major challenge for ITOCHU ENEX going forward.

Meanwhile, LP gas operators face the need to further strengthen their governance, as new regulations regarding proper transactions and transparency of rates have been introduced based on the Liquefied Petroleum Gas Act.

To respond quickly to these changes and strengthen its business competitiveness, ITOCHU ENEX has decided to merge four Group companies primarily engaged in the LP gas sales business: ITOCHU ENEX HOME-LIFE NISHI-NIHON CO., LTD., ITOCHU ENEX HOME-LIFE HOKKAIDO CO., LTD., ITOCHU ENEX HOME-LIFE TOHOKU CO., LTD., and ITOCHU ENEX HOME-LIFE SHIKOKU CO., LTD.

The new company will operate the Home-Life Division's LP gas sales business and operating companies, while aiming to further expand its business base.
